Enclosed are tentative Waste Discharge Requirements and a draft Cease and Desist Order for the Tejon-Castac Water District, Tejon Industrial Complex Wastewater Treatment Facility. The previous WDRs name the Tejon Ranchcorp as responsible party for the WWTF discharge. The subject tentative draft orders name the Tejon-Castac Water District as the responsible party. Please review Finding 1 of the draft WDRs and confirm its accuracy.
